In petitioning this court for a writ of mandamus, the relator seeks "an order directing the respondent court to issue the writ of habeas corpus." Such a writ is an order issued out of a court of general jurisdiction by one of its own judges to a judge of an inferior court. The writ has been defined in Texas as "the legal proceeding by which a court of competent jurisdiction issues an order compelling a district or inferior court to perform a legal duty." Supreme Court Rules 191 and 192, Texas Rules of Civil Procedure. Relator herein obtained from the district judge of Harris County a contempt judgment against relator. This is true of all contempts, whether civil or criminal. Article 1911, Vernon's Ann.Tex.Civ.St. Thus, relator obtained from the district judge of Harris County a writ of habeas corpus, which is a judgment directing the respondent inferior court or judge to take the relator before the district court and there issue a writ of habeas corpus. He was before the respondent judge with that writ and they made no order thereon. While the writ of habeas corpus is a legal device which comes into play in the handling of relator's charge of contempt by the respondent judge, no order of this court can direct the respondent judge to perform any action. Furthermore, the only question presented in this proceeding is whether relator has a right of appeal from the contempt judgment rendered by the respondent judge. Under Art. 1911, it is the duty of that judge to determine if the relator has a right of appeal from that judgment. Such judgment, being a final one, may not be appealed. This court may not issue an original mandamus which would order this respondent court to issue a writ of habeas corpus. On the other hand, the respondent judge can do nothing about the writ of habeas corpus which he granted on the face of the record to the relator. That part of the application for the writ which seeks an order compelling the trial judge to transfer the relator to the county jail for her refusal to pay the fine stated in the contempt judgment is a petition for a writ of mandamus. However, since there is no order on the motion of respondent judge to transfer relator to the county jail and no judgment entered there
